Trustees' Report 31 August 2022

The trustees of Urbis Academy Trust ('the Academy') present their annual report together with the financial statements and the auditor's reports of the charitable company for the year to 31 August 2022. The annual report serves the purposes of both a trustees' report and a directors' report under company law.

The financial statements have been prepared in accordance with the accounting policies set out on pages 31 to 36 of the attached financial statements and comply with the Academy's memorandum and articles of association, applicable laws and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102).

For the year ended 31 August 2022, Mayville Primary School was the only school within Urbis Academy Trust.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

The academy trust is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the academy trust. The trustees of The Urbis Academy Trust are also the directors of the charitable company for the purposes of company law. The charitable company is known as The Urbis Academy Trust.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

Trustees' indemnities

Trustees' Indemnity Insurance (including Professional Liability) provides cover up to £10,000,000.

Principal activities

As stated in the Articles of Association, the Academy's objects ("the objects") are specifically restricted to the following:

The charitable company was created with the objective to advance for the public benefit of education in the United Kingdom, in particular, but without prejudice to the generality of the foregoing by establishing, maintaining, carrying on, managing and developing a school offering a broad and balanced curriculum ("the Academy").

Method of recruitment and appointment or election of trustees

In addition to direct advertising for new trustees, Trustees for Schools was used and we also use London Borough of Waltham Forest governor services to assist in the recruitment of new trustees, detailing specific skills required, for example; finance, personnel, education, premises and law.

Policies and procedures adopted for the induction and training of trustees

Induction and training procedures for trustees are in place and take the form of formal training sessions run by London Borough of Waltham Forest; these cover all areas of governance. Logs of training courses are held on the Trust's website. The trust has a link trustee who monitors training requirements and identifies relevant courses which fit with the trusts objectives and priorities. The Urbis Academy Trust adopts a Governor Code of Conduct that acts as reference for trustees and outlines the expectations and responsibilities of their role.

Organisational structure

The aim of the management structure is to delegate responsibility and encourage involvement in decision making at all levels.

The trustees are responsible for setting overall policy, adopting an annual plan and budget, monitoring the academy by the use of budgets and making major decisions about the direction of the academy, capital expenditure and senior staff appointments.

The full Board of Trustees has delegated some duties and powers to committees as appropriate which currently includes the Audit/Risk Committee and Curriculum Committee.

STRUCTURE, GOVERNANCE AND MANAGEMENT (continued)

Organisational structure (continued)

During the academic year Trustees held five full Governing Body meetings, preceded by four committee meetings annually.

Appropriate powers and functions are delegated to the Headteacher and include responsibility for the internal organisation, management and control of the academy, the implementation of all policies approved by the Board of Trustees and the direction of teaching and the curriculum.

Arrangements for setting pay and remuneration of key management personnel

The key management personnel of The Urbis Academy Trust are the trustees and the Senior Management Team including the Headteacher, Deputy Headteacher, Assistant Headteacher, the School Business Manager and the Assistant Headteacher. The remuneration of these key personnel is managed, approved and is benchmarked against comparable roles in other schools by the Headteacher in line with the Finance Policies delegation of duties. Trustees are not remunerated for their services as trustees of the Academy Trust.

Trade union facility time

The School has two members of staff, both staff work part time. One is a teacher and the other is a member of support staff who were relevant union officials during the relevant period. Percentage of time spent on facility time is 8% and 6% respectively.

Comparing the data for 2021 to 2022, it is possible to see the effects that the COVID -19 lockdowns had on pupil attainment. Last year was a smaller cohort and 2022's pupils were out of school longer than the year 6 pupils in 2021. SPaG, reading and writing were lower than 2021, but maths bucked the trend and the pupils scored 1% higher than the previous year. Pupil Premium students scored on average 4% lower than non-pupil premium students.

The refining of subjects within the Curriculum is the focus for this academic year and ensuring that the curriculum for all subjects is firmly embedded. External monitoring has taken place and has confirmed that this is the case. Subject leads have received training from the academies National Leader in Education.

STRATEGIC REPORT (continued)

Financial review

Financial report for the year

The results for the year are shown in full on page 28.

Total income for the year ended 31 August 2022 amounted to £2,424,000 (2021 -£2,403,000). The major part of this income was receivable from the Education and Skills Funding Agency (ESFA), an agency of the Department for Education, the use of which is restricted to particular educational purposes.

Total expenditure for the year ended 31 August 2022 (after depreciation and adjustments in respect of the Local Government Pension Scheme (LGPS) liability) was £2,862,000 (2021 - £2,770,000). The major part of this expenditure was in relation to the Academy Trust's staff costs which for the year ended 31 August 2022 totaled £1,989,000 (2021 - £1,979,000).

Net expenditure for the period was £438,000 (20201— net expenditure of £367,000). After accounting for net actuarial gains on the defined benefit pension scheme of £963,000 (2021— net losses of £197,000), the overall net increase in funds amounted to £525,000 (2021— net decrease in funds of £564,000).

After excluding movements on the fixed asset and pension deficit funds, the operational deficit for the year was £18,000 (2021 – operational surplus of £11,000).

Financial position

The Academy had total funds of £11,957,000 (2021 - £11,432,000) at the balance sheet date, including a fixed assets fund of £12,707,000 (2021 - £12,995,000) (representing the carrying value of the Academy Trust's tangible fixed assets used in its day-to-day operations) and a deficit on the pension reserve of £799,000 (2021 - £1,630,000) (representing the latest estimate of the Academy Trust's share of the deficit in the Local Government Pension Scheme).

Excluding the fixed assets fund and the pension reserve, the Academy Trust held unrestricted income funds of £34,000 (2021 - £67,000) and restricted income funds of £15,000 (2021 - £nil). Collectively, the unrestricted and restricted income fund total £49,000 (2021 - £67,000) and these are effectively the Academy Trust's operational, or revenue reserve, which are available to the Academy Trust to meet day-to-day contingencies.

Financial and risk management objectives and policies

Risks are defined as uncertain future events that might prevent the academy trust from achieving its objectives. The trustees therefore ensure that it has in place the means to identify, analyse, control and monitor the strategic and operational risks it faces through its Fraud Policy, Risk Register & Business Continuity Plan.

STRATEGIC REPORT (continued)

Financial review (continued)

Reserves policy

Trustees review the reserves of the Academy to ensure that they are adequate to meet the needs of the Academy. On conversion to academy trust status, the trustees required a revenue reserve to be created to fund future expenditure related to the Academy Development Plan's strategic long-term aims and developments.

The policy of the Academy is to carry forward a prudent level of resources designed to meet the long-term cyclical needs of renewal and any other unforeseen contingencies, subject to the constraint that the level of resources does not exceed the level permitted by the DfE.

The trustees have set a minimum level of reserves of £100,000 to be maintained by the Academy. As noted above, as at 31 August 2022, the Academy had revenue reserves including unrestricted and restricted revenue funds of £49,000 (2021 - £67,000) and therefore the minimum reserves requirement set by the trustees was not achieved at the balance sheet date.

A detailed plan has been put into place in order to protect the financial position of the Academy Trust. This action plan includes careful management of expenditure as far as possible in order to ease cash flow until reserves recover from the significant legal and additional staffing costs incurred during 2018/19 and 2019/20. The Academy has a Delegated Authority Listing, this states expenditure to be approved by the Audit/Risk committee, whilst building reserves.

Reserves held at year-end are considered sufficient to meet the School's current and expected needs for the short term, subject to the uncertainties disclosed in the Going Concern section of this report below, and within the principal accounting policies accompanying the financial statements.

Going concern

After making appropriate enquiries, the Board of Trustees has a reasonable expectation that the Academy Trust has adequate resources to continue in operational existence for a period of at least 12 months from the date of approval of this report.

As detailed in the reserves policy above, the total revenue reserves carried forward as at 31 August 2022 were £49,000 (2021 - £67,000). This is lower than the target level of reserves as stipulated in the reserves policy (£100,000), but an action plan has been put into place to ensure that the Academy Trust can recover its reserves position, which has arisen largely due to the losses resulting from the legal and HR cases which were ongoing throughout 2018/19 and 2019/20. The management accounts as at 30 September 2022 forecasts an in-year surplus of £67,000.

STRATEGIC REPORT (continued)

Going concern (continued)

The trustees do, however, recognise that there are a number of challenges in achieving this recovery in the short term, particularly given the more recent cost pressures resulting from high and fluctuating rates of inflation, and uncertainties which exist around the extent of future funding which will be made available by Government in support of these issues. Therefore, whilst the trustees are of the opinion that the financial statements should be prepared on a going concern basis, they have indicated that there are material uncertainties which exist in relation to this assessment.

Investment policy

The trustees will consider the investment of surplus funds of the Academy should future circumstances require, in accordance with the Academies Handbook.

Fundraising

The Academy Trust has not undertaken any fundraising activity during the year. The PTA raise money for the school by holding events.

PRINCIPAL RISKS AND UNCERTAINTIES

The trustees have established a risk management policy and a risk register in order to manage the strategic and operational risks to which the Academy is exposed. The principal risks specific to Mayville Primary School include:

- Health risks to staff and pupils in relation to the ongoing Covid-19 pandemic.
- Failure to recruit sufficient pupils in order to make the school viable due to the demographic changes in London Borough of Waltham Forest. Pupil numbers have significantly reduced. House prices have significantly increased, so the larger families in the area have been relocated to Welwyn in Hertfordshire and Luton. The pupil admission number is now 60 pupils per year.
- The falling number of nursery and primary school aged children in Waltham Forest. After extensive research, the Academy has introduced a full-time Nursery. This attracts working families who need full time care and is proving to be successful.
- Failure to monitor and react to the risks regarding competitor establishments.
- Any damage to the Academy Trust's reputation could have an adverse impact on the pupil roll given that school places exceed pupil numbers in the borough.

The Academy is working to mitigate these three risks by raising awareness to residents in the local area through marketing in order to ensure that pupil recruitment remains sufficient. In addition, maintaining a strong reputation for quality of education and value added will enhance the Academy's ability to recruit pupils.

PRINCIPAL RISKS AND UNCERTAINTIES (continued)

A detailed COVID-19 Risk Assessment has been implemented and still exists, this was sent to London Borough of Waltham Forest.

In March 2021 the Trust consulted on a restructure which was implemented in September 2021. The restructure was to change the number of Assistant Headteachers, recruit a Deputy Headteacher and have only one Site Services Officer. In addition to this the posts of Learning Mentors were removed, the contracted hours of the LSA's and Administration team were changed, whilst two year olds were no longer accepted into the Nursery. From September 2021 all teaching staff commencing employment have been placed on the Outer London main pay scale.

Recruitment processes are managed at the Academy to ensure suitable candidates are sourced. Staff training and retention is also given high priority within the Academy in order to ensure that quality and retention is maintained.

PLANS FOR FUTURE PERIODS

The Academy Trust's objectives are:

- To support our pupils to achieve their ambitions is at the heart of all that we do. We will deliver innovative programmes that challenge and stretch, underpinned by tailored educational and therapeutic support where needed. New technologies are being used to track progress and achievement through data monitoring. We will develop the skills and knowledge base of all staff through a comprehensive Continuous Professional Development offer and rigorous quality monitoring.
- The rich and varied curriculum that has been introduced in both formal lessons and extracurricular activities has a substantial and positive impact on pupils' spiritual, moral, social and cultural development.
- The Academy aims to improve the Ofsted rating in the coming year and works with other Waltham Forest schools to ensure Best Practise.
- The school continues to improve progress and attainment results year on year, this are evidenced in the results of pupils at the end of their key stages.
- The Academy will continue to improve the effectiveness and efficiency of the financial systems.
- Ensure appropriate risk management and options appraisal of operations.
- External finance audit demonstrates effective practise.

Scope of responsibility

As trustees, we acknowledge we have overall responsibility for ensuring that the Urbis Academy Trust has an effective and appropriate system of control, financial and otherwise. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives and can provide only reasonable and not absolute assurance against material misstatement or loss.

The board of trustees has delegated the day-to-day responsibility to the Headteacher, as accounting officer, for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the funding agreement between the Academy and the Secretary of State for Education. The Headteacher is also responsible for reporting to the board of trustees any material weaknesses or breakdowns in internal control.

Governance

The information on governance included here supplements that described in the trustees' report and in the statement of trustees' responsibilities. The board of trustees has formally met 5 times during the period. The trustees believe that the frequency of meetings, alongside the support of the sub-committees discussed below, allowed effective oversight of the Academy Trust's operations and finances. Conflicts of interest

Governance reviews

The review of governance arrangements on conversion included a review of the committee structure, membership of committees and also the establishment of appropriate policies for the academy trust.

A Governance review has been arranged and will be completed before the end of term. A full Governance review was completed by Browne Jacobson. This has now been analysed and training sessions for Trustees have been arranged to address any weaknesses. The Chair of Trustees commissioned a full safeguarding review. This was completed on 7 October 2018. All Trustees were invited to Safeguarding training on 1 September 2022

A review of the governance arrangements is carried out on an annual basis.

The Audit/Risk Committee is a sub-committee of the main board of trustees. Its purpose is to oversee the finances of the Academy and oversee risk management and assurance arrangements.

The Board maintains effective oversight over the Trust's finances by meeting five times per year and reviewing the reports of its dedicated sub-committees.

Review of value for Money

As accounting officer, the Headteacher has responsibility for ensuring that the academy trust delivers good value in the use of public resources. The accounting officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The accounting officer considers how the trust's use of its resources has provided good value for money during the academic year, and reports to the board of trustees where value for money can be improved, including the use on benchmarking data where available. The accounting officer for the academy trust has delivered and improved value for money during the year by:

Review of value for Money (continued)

Raising Student Attainment

After analysing student attainment in Key Stages 1 and 2, the academy has made a number of key appointments which are focused on raising standards, thus ensuring better value for money.

Financial Governance

An independent and appropriately qualified Chief Financial Officer ensures compliance with ESFA Regulations regarding management of finance and delivering value for money. This is reported to the Audit/Risk Committee at least four times a year.

A qualified Accountant has been appointed as a Responsible Officer, who scrutinises all the Trust Practices. This helps ensure outstanding management of finances to ensure the best possible value for money.

Procurement (Better Purchasing)

The School Business Manager has enabled the Trust to develop better systems for the procurement of goods and services and project management of buildings. All contracts have been analysed and re-negotiated, to ensure the Academy is gaining the most economical, efficient and effective use of all resources. A rigorous tendering and accounting policy has been implemented to ensure this occurs with all contracts.

Reviewing Controls and Managing Risks

On conversion to an Academy, the Trust purchased PS Financials, an accounting package that produces all necessary reports. Monthly budget monitoring reports are produced and reviewed by the School Business Manager, a finance specialist and the accounting officer. Thus, monitoring the exact financial position of the Academy at all times. The Trustees receive monthly management accounts.

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an ongoing process designed to identify and prioritise the risks to the achievement of the Academy's policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place at the Academy for the year ended 31 August 2022 and up to the date of approval of the annual report and financial statements.

Capacity to handle risk

The board of trustees has reviewed the key risks to which the Academy is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The board of trustees is of the view that there is a formal ongoing process for identifying, evaluating and managing the Academy's significant risks that has been in place for the year ended 31 August 2022 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the board of trustees.

The risk and control framework

A detailed COVID-19 Risk Assessment has been implemented, this is also sent to London Borough of Waltham Forest.

The Academy's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the board of trustees;
- trustees receive monthly Management accounts;
- regular reviews by the resources and audit committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes;
- setting targets to measure financial and other performance;
- clearly defined purchasing (asset purchase or capital investment) guidelines;
- delegation of authority and segregation of duties;
- identification and management of risks.

During the 2021/22 academic year, Landau Baker were appointed to carry out a programme of internal checks on the Academy Trust's financial systems and they reported their findings to the Board through the Risk/Audit Committee. In particular, the checks carried out in the current period included internal controls and payroll processes and procedures.

Review of effectiveness

As accounting officer, the Headteacher has responsibility for reviewing the effectiveness of the system of internal control. During the period in question, the review has been informed

- the work of the external auditor;
- the additional internal assurance work carried out by the external auditor;
- the financial management and governance self assessment process;
- the work of the senior management team within the Academy who have responsibility for the development and maintenance of the internal control framework.

Opinion

We have audited the financial statements of Urbis Academy Trust (the 'charitable company') for the year ended 31 August 2022 which comprise the statement of financial activities, the balance sheet, the statement of cash flows, the principal accounting policies and the notes to the financial statements. The financial reporting framework that has been applied in their preparation is applicable law, United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice), Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (the Charities SORP (FRS 102)) and the Academies Accounts Direction 2021 to 2022.

In our opinion, the financial statements:

- give a true and fair view of the state of the charitable company's affairs as at 31 August 2022 and of its income and expenditure, for the period then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice;
- have been prepared in accordance with the requirements of the Companies Act 2006;

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the charitable company in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Material uncertainty relating to going concern

Whilst the financial statements for the year ended 31 August 2022 have been prepared by the trustees on a going concern basis, as indicated by the trustees within their assessment of going concern contained within the principal accounting policies accompanying the financial statements, the trustees believe there are material uncertainties which exist in relation to this assessment arising from the challenging economic circumstances, particularly given the more recent cost pressures resulting from high and fluctuating rates of inflation, and uncertainties which exist around the extent of future funding which will be made available by Government in support of these issues.

Material uncertainty relating to going concern (continued)

The trustees also note that the level of operational reserves held by the Academy Trust at 31 August 2022 of £49,000 (represented by £15,000 of restricted income funds and £34,000 of unrestricted income funds) falls short of the target reserves level of £100,000 further increasing this challenge.

In light of these circumstances, we have considered the adequacy of disclosures made by the trustees pertaining to the going concern assumption in the preparation of these financial statements and their assessment of the associated uncertainties and concur with their conclusions.

The trustees' assessment of the going concern position is disclosed as part of the principal accounting policies at page 31. We bring these disclosures to the attention of the members.

In auditing the financial statements, we have concluded that the trustees' use of the going concern basis of accounting in the preparation of the financial statements is appropriate. Our opinion is not modified in respect of this matter.

Our responsibilities and the responsibilities of the directors with respect to going concern are described in the relevant sections of this report.

Other information

The trustees are responsible for the other information. The other information comprises the information included in the annual report other than the financial statements and our auditor's report thereon. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

We corroborated our inquiries through our review of the minutes of trustees' meetings and papers provided to the trustees; and
- we planned and carried out a separate limited assurance engagement in respect of regularity, propriety and compliance in accordance with the Framework and Guide for External Auditors and Reporting Accountants of Academy Trusts issued by the ESFA, as set out in our separate independent reporting accountant's assurance report on regularity.

Statement of accounting policies

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgements and key sources of estimation uncertainty, is set out below.

Basis of preparation

The financial statements of the academy trust, which is a public benefit entity under FRS 102, have been prepared under the historical cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2021 to 2022 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

Urbis Academy Trust meets the definition of a public benefit entity under FRS 102.

The financial statements are presented in pounds sterling and are rounded to the nearest thousand.

Going concern

The Trustees assess whether the use of going concern is appropriate i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the company to continue as a going concern. The Trustees make this assessment in respect of a period of at least one year from the date of authorisation for issue of the financial statements.

As detailed in the reserves policy above, the total revenue reserves carried forward as at 31 August 2022 were £49,000 (2021 - £67,000). This is lower than the target level of reserves as stipulated in the reserves policy (£100,000), but an action plan has been put into place to ensure that the Academy Trust can recover its reserves position which has arisen largely due to the losses resulting from the legal and HR cases which were ongoing throughout 2018/19 and 2019/20. The management accounts as at 30 September 2022 forecasts an in-year surplus of £67,000.

The trustees do, however, recognise that there are a number of challenges in achieving this recovery in the short term, particularly given the more recent cost pressures resulting from high and fluctuating rates of inflation, and uncertainties which exist around the extent of future funding which will be made available by Government in support of these issues. Therefore, whilst the trustees are of the opinion that the financial statements should be prepared on a going concern basis, they have indicated that there are material uncertainties which exist in relation to this assessment.

Income

All income is recognised when the academy trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

Grants

Grants are included in the statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

The General Annual Grant is recognised in full in the statement of financial activities in the year for which it is receivable and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended. Unspent amounts of capital grant are reflected in the balance in the restricted fixed asset fund.

Donations

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

Other income

Other income, including the hire of facilities, catering income, school trips, full time nursery provision and after school club, is recognised in the period it is receivable and to the extent the academy trust has provided the goods or services.

Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity.

Charitable activities

These are costs incurred on the academy trust's educational operations, including support costs and costs relating to the governance of the academy trust apportioned to charitable activities.

All expenditure is stated net of recoverable VAT.

Tangible fixed assets

Assets costing £1,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance Sheet at cost and depreciated over their expected useful economic life. The related grants are credited to a restricted fixed asset fund in the statement of financial activities and carried forward in the Balance Sheet. Depreciation on such assets is charged to the restricted fixed asset fund in the statement of financial activities so as to reduce the fund over the useful economic life of the related asset on a basis consistent with the Academy's depreciation policy. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

Depreciation is provided on all tangible fixed assets other than freehold land, at rates calculated to write off the cost/valuation of each asset on a straight-line basis over its expected useful economic life, as follows:

Long leasehold buildings
 2% per annum

Furniture and equipment
 25% per annum

Depreciation is charged from the month of acquisition.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the statement of financial activities.

Stock

Stock is valued at the lower of cost or net realisable value.

Debtors

Debtors are recognised at their settlement amount less any provision for non-recoverability. Prepayments are valued at the amounts prepaid. They have been discounted to the present value of the future cash receipt where such discounting is material.

Cash at bank and in hand

Cash at bank and in hand represents such accounts and instruments that are available on demand. Notice deposits are included on the balance sheet as short term deposits.

Liabilities

Liabilities are recognised when there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the academy trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

Leased assets

Rentals under operating leases are charged on a straight line basis over the lease term.

Financial instruments

The academy trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the academy trust and their measurement basis are as follows:

Financial assets – trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments. Amounts due to the charity's wholly owned subsidiary are held at face value less any impairment.

Cash at bank - is classified as a basic financial instrument and is measured at face value.

Financial liabilities – trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument. Amounts due to charity's wholly owned subsidiary are held at face value less any impairment.

Taxation

The Academy is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the Academy is potentially exempt from taxation in respect of income or capital gains received within categories covered by Chapter 3 Part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Pensions benefits

Retirement benefits to employees of the academy trust are provided by the Teachers' Pension Scheme ('TPS') and the Local Government Pension Scheme ('LGPS'). These are defined benefit schemes.

Pensions benefits (continued)

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the academy trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective unit credit method. As stated in note 17, the TPS is a multi-employer scheme and there is insufficient information available to use defined benefit accounting. The TPS is therefore treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

The LGPS is a funded scheme and the assets are held separately from those of the academy trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the statement of financial activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

Fund accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the Academy at the discretion of the governors.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by the Education and Skills Funding Agency, Department for Education or other funders where the asset acquired or created is held for a specific purpose.

Restricted income funds comprise all other grants received from the Education and Skills Funding Agency, the Local Authority or other revenue funds that are given for specific purposes.

Critical accounting estimates and areas of judgement

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and areas of judgement (continued)

Critical accounting estimates and assumptions

The academy trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost (income) for pensions include the discount rate. Any changes in these assumptions will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2022. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Each member of the charitable company undertakes to contribute to the assets of the company in the event of it being wound up while he/she is a member, or within one year after he/she ceases to be a member, such amount as may be required, not exceeding £10 for the debts and liabilities contracted before he/she ceases to be a member.

17 Pension and similar obligations

The academy trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by London Borough of Waltham Forrest. Both are multi-employer defined benefit schemes.

The latest actuarial valuation of the TPS and the LGPS related to the period ended 31 March 2019.

There were no outstanding or prepaid contributions at either the beginning or the end of the financial year.

Teachers' Pension Scheme

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for teachers in academies. All teachers have the option to opt-out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary - these contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

Valuation of the Teachers' Pension Scheme

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% administration levy);
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million, giving a notional past service deficit of £22,000 million; and
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI. The assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2024.

The employer's pension costs paid to TPS in the period amounted to £193,593 (2021 -£195,978).

A copy of the valuation report and supporting documentation is on the Teachers' Pension Scheme website.

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The academy trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The academy trust has set out above the information available on the scheme.

Local Government Pension Scheme (LGPS)

The LGPS is a funded defined-benefit scheme, with the assets held in separate trustee-administered funds. The total contribution made for the year ended 31 August 2022 was £174,000 (2021 – £178,000), of which employer's contributions totalled £142,000 (2021 – £145,000) and employees' contributions totalled £32,000 (2021 – £33,000).

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of the Academy Trust's closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.
